 - Participate in strategic planning, providing input and serving as a sounding board for plan development and on-going discussion of emerging issues and opportunities;
 - Members' staff with relevant expertise in particular areas participate on Network committees;
 - Serve as a connector with current and potential community partners; and
 - Prompt, consistent communication regarding Network activities and issues to be addressed/explored with the Alliance's staff.



- B. Responsibilities and provisions of GRASSA to its members include:
 - Provide members with emerging knowledge, resources, best practices;
 - Provide a collective voice in championing systems-level high-quality OST;
 - Prompt, consistent communication regarding Alliance activities and Systems issues related to OST
 - Provide professional development opportunities;
